Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. **Date,time and Venue of OTR Verification will be published shortly.**

Note :- (5) Candidates belong to Other Backward Classes included in the Short List , eligible for reservation are required to produce Non Creamy Layer Certificate as per G.O (P) No.81/09/SCSTDD dated 26.09.2009 or that obtained through e-district portal in the format prescribed in G.O (Rt) No.3942/2018/RD dated 24.09.2018 and candidates who claim EWS reservation are required to produce EWS Certificate vide G.O.(MS)No.3/2024/P&ARD dated 25.04.2024 issued by the Revenue Authority along with other documents at the time of OTR verification of original documents.

Note :- (6) For Online Examination , rechecking and revaluation are not allowed but printout of answer sheets will be issued to those candidates who apply for it by remitting the prescribed fee after the publication of Ranked List. Detailed instructions will be furnished in the Ranked List to be published for the post.
