Note :- (3) 10(Ten) candidates who have secured top most marks in the OMR Examination are included in the MainList of the Short List.The marks secured by the last candidate in the Main List is 40.33 (forty(point) three three). For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes,Economically Weaker Section, necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification.Date, Time and Venue of OTR Verification and Interview will be intimated through Profile Message and SMS.

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates included in the Short List belonging to Other Backward Classes are required to produce NonCreamy Layer Certificate issued by Village Officer as per GO(P) No.81/2009/SCSTDD Dtd.26.09.2009, SC/STCandidates are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificate Rules 2002 by the Revenue authority not below the Rank of Tahsildar and candidates claiming reservation under EWS category are required to produce Income and Asset certificate issued by Village Officer as per GO (Ms) No. 2/2020/P&ARD Dtd. 12.02.2020 as proof of their claim, along with other relevant documents at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on 28-06-2024 will be issued to those candidates who, applyfor the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated vide notification NO:.ER16-1/13/2024-KPSC- dated 03.09.2024
