The marks secured by the last candidate in the Main List is **42.67 (forty two (point) six seven)** marks. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes and Economically Weaker Section, necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidate included in the Short List should present in person and produce the original documents for Interview and One Time Verification. Date, time and Venue of Interview and OTR Verification will be intimated through Profile message and SMS.

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging Other Backward Classes included in this list are required to produce Non Creamy Layer Certificate as per G.O.(P) No.81/2009/SC/STDD dated 26.09.2009, candidates belonging to SC/ST are required to produce Community Certificate in Form III or Digitally Signed issued by the Revenue Authority not below the rank of Thahildar and candidates belonging to Economically Weaker Section are required to produce EWS Certificate vide G.O(MS) No.2/2020 P&ARD dated 12.02.2020 issued by the concerned authority at the time of OTR verification.

Note :- (7) Copy of answer scripts of the OMR Test held on 28-06-2024 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Answer Scripts of no candidates are invalidated as per Notification No :ER16-1/13/2024-KPSC dated 03.09.2024.
