

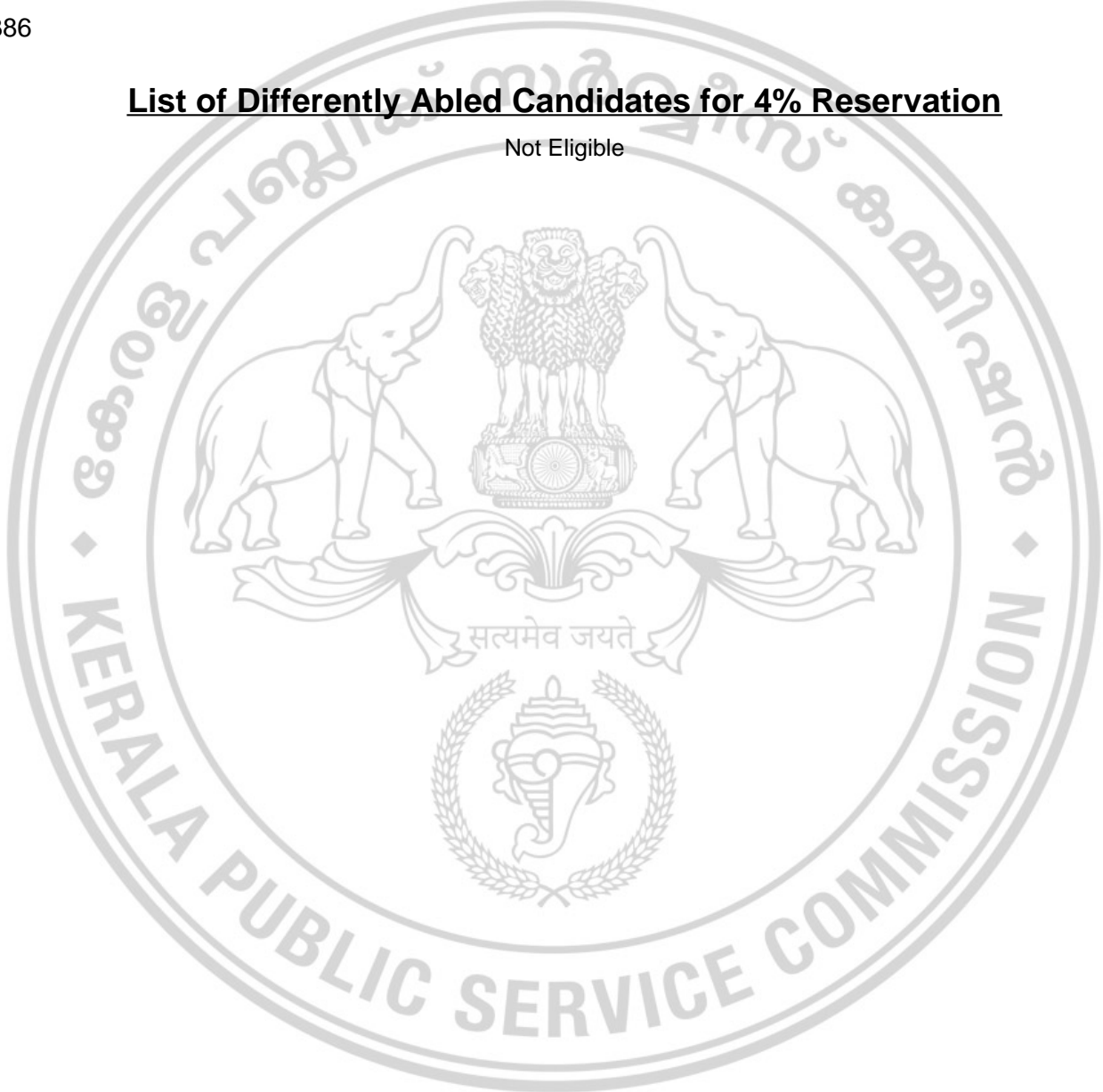

Note :- (5) Candidates belong to SC/ST Community included in the Short List are required to produce Community Certificate issued by the Revenue authority and candidates belong to Other Backward Classes included in the Short List are required to produce Non-Creamy Layer Certificate as per GO(P)No.81/09/SC/ST DD dated 26/09/2009 issued by the Revenue authority and candidates belong to EWS category are required to produce EWS certificate issued by the Revenue Authority at the time of OT Verification.

Note :- (6) The register number of those candidates who do not produce the required documents within prescribed time limit and whose applications found otherwise defective will be deleted from the Short List without further notice.

Note :- (7) Copy of answer scripts of the OMR Test held on **05-09-2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
