

For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Shcheduled Tribes, Other Backward Classes ( and other reserved Categories if any ) necessary supplementary lists prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (3) Candidates included in the Probability List should present in person and produce the original documents for One Time Verification. Date, Time and Venue of OTR Verification will be intimated in due course.

Note:- (4) The Probability List is prepared based on the details furnished by the candidates in the application and subsequent claims made will not be entertained at any stage.

Note:- (5) According to the existing procedure, revaluation of answer scripts is not allowed. But answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates included in the Probability List who belong to Other Backward Classes are required to produce Non- Creamy Layer Certificate issued by Village Officer as per GO(P) No.81/09/SC/STDD dated.26.09.2009, SC/ST Candidates are required to produce Community Certificate (in Form III/ Digitally signed) by the Competent authority not below the Rank of Thasildar and candidates claiming reservation under EWS category are required to produce EWS Certificate issued by Village Officer as per GO(Ms) No.2/2020/P&ARD dated 12.02.2020 along with other documents at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **04-05-2024** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated as per Notification No : ER2-1/12/2024-KPSC daed 29.10.2024.
