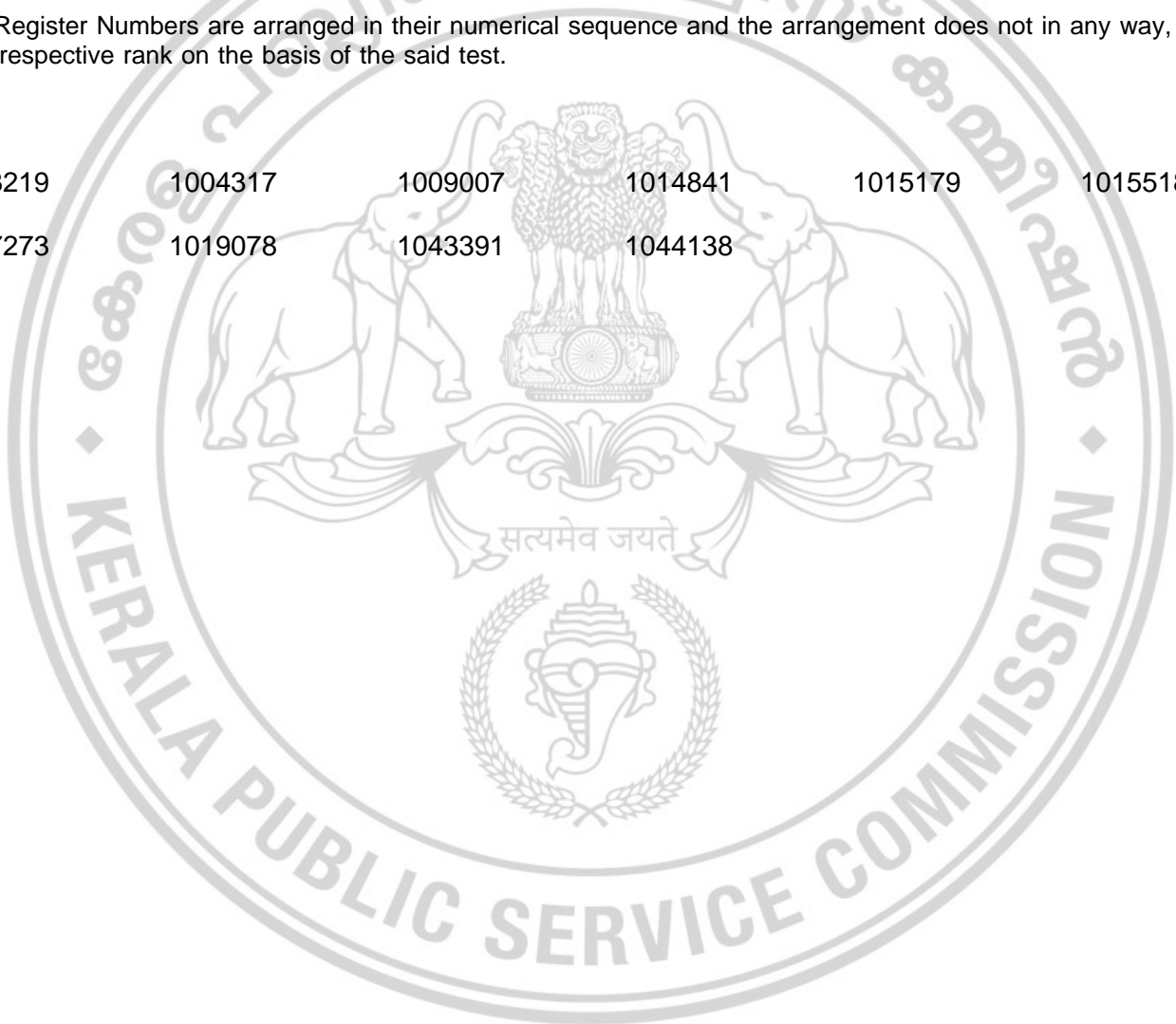

Note :- (6) Candidates included in the Short List are required to produce Non Creamy Layer Certificate issued by the Revenue authority at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **20-07-2024** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. As per the invalidation Notification No: **ER16-3/17/2024-KPSC dated 21.10.2024**, of The Secretary, KPSC, Thiruvananthapuram, no answer scripts are invalidated for the above post .
