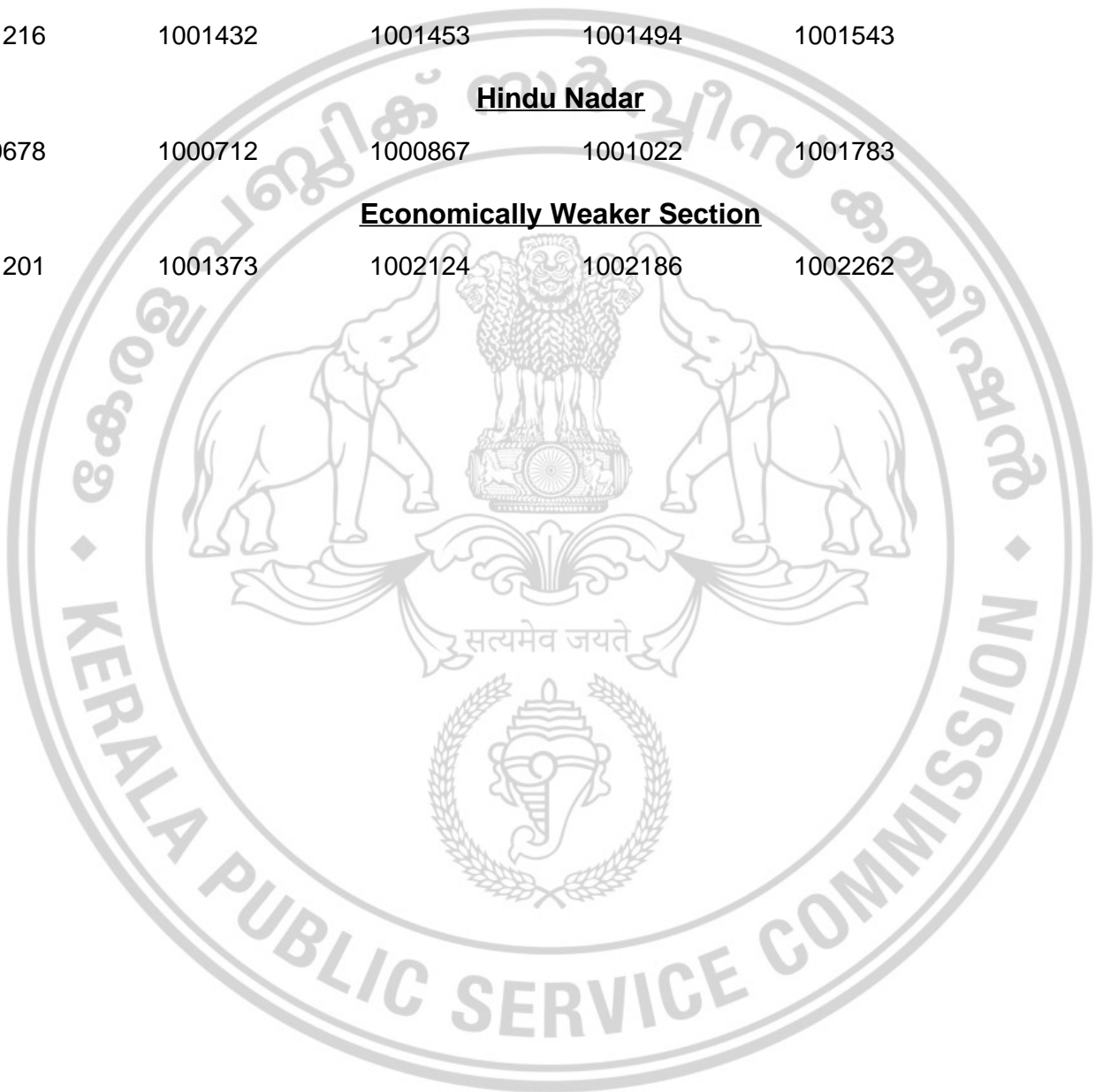

Note :- (2) The list has been prepared by including the number of candidates who have secured top marks in the OMR Test.

Note :- (3) The Short list is prepared based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage.

Note :- (4) 20(Twenty) candidates who have secured top marks in the OMR Examination are included in the Main List of this Short List. The Mark secured by the last candidate in the Main List is **63 ( sixty three )**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, other backward classes and economically weaker sections, necessary supplementary lists are prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (5) Candidates included in the Short List should present in person and produce the original documents for One Time Verification. **Date, time and Venue of OTR Verification will be published shortly.**

Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) Candidates belonging to SC/ST included in the Short List are required to produce Community Certificate issued by the competent Revenue Authority and candidates belonging to Other Reservation Groups are required to produce Non Creamy Layer Certificate as per G.O(P)No.81/2009/SCSTDD dated 26/09/2009 issued by Village officer. Candidates who claim EWS reservation are required to produce EWS Certificate as per GO(MS)No.23/2022/P&ARD dated 18.10.2022 issued by the Village Officer in proof of their claim along with other relevant documents at the time of OTR Verification.

Note :- (8) Copy of answer scripts of the OMR Test held on **09-07-2024** will be issued to those candidates who apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : ER4-2/14/2024-KPSC Dated 07 .11.2024.
