Note:- (2) The list has been prepared by including the number of candidates who have secured top marks in the OMR Test. The Probability List is prepared based on the details furnished by the candidate in the application and subsequent claims will not be entertained at any stage.

Note:- (3) 74 (Seventy Four) candidates who have secured top most marks in the OMR examination are included in the mainlist of this Probability List. The marks secured by the last candidate in the Main List is 59(fifty nine) marks. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes and Economically Weaker Section, necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note:- (4) Candidates included in the Probability List should be present in person and produce the original documents for One Time Verification. Date, time and Venue of One Time Verification will be intimated through Profile Messages and SMS in due course.

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to Other Backward Classes included in this list are required to produce Non Creamy Layer Certificate as per G.O.(P) No.81/2009/SC/STDD dated 26.09.2009, candidates belonging to SC/ST are required to produce Community Certificate in Form III or Digitally Signed issued by the Revenue Authority not below the rank of Thahsildar and candidates belonging to Economically Weaker Section are required to produce EWS Certificate vide G.O(MS) No.2/2020 P&ARD dated 12.02.2020 issued by the concerned authority along with other documents at the time of OTR verification.

Note :- (7) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Probability List without further notice.

Note:- (8) Copy of answer scripts of the OMR Test held on 13.05.2024 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No:ER.XIV(3) /05/2024-KPSC dtd 23/11/2024
