NOTE (1):- The Ranked List will be in force till the publication of a new ranked list after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. Candidates from the Ranked List will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendancy of the Ranked List. As the advice for appointment depends on the occurance of vacancies there is no gauarantee that all the candidates included in the Ranked List will secure appointment. The candidates remaining in the Ranked List at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the Ranked List.

NOTE (2):- According to the existing procedure, revaluation of Answer script is not allowed. But OMR Answer scripts will be rechecked if the candidates apply for through their One Time Registration profile from the Commission's official website www.kerala psc.gov.in by remitting the prescribed fee of Rs. 85 (Rupees Eighty Five only). The fee can be remitted by e-payment through the portal. Applications submitted in any other manner will not be considered. A period of 15 (fifteen) days time to apply for rechecking of Answer scripts will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission.(on or before 26.12.2024). The candidates can avail only one chance after the Approval of Ranked List. Rechecking of invalidated answer scripts due to any defects will not be considered. Application for Rechecking received after the stipulated time will not be entertained and Fee once remitted will not be refunded.

NOTE (3):-Candidates who wish to obtain a photocopy of their OMR Answer sheets (Part A & Part B) relating to this selection shall submit online application through their One Time Registration profile from the official website of the Commission, www.keralapsc.gov.in by remitting the prescribed fee of Rs.335/- (Rupees three hundred and thirty five) via e-payment mode available in the portal. A period of 15 ((Fifteen) days time to apply for photocopy of OMR sheets will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission. Application submitted in any other manner will not be considered. A copy of the answer sheet will be issued only once to a candidate. Copies of OMR sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date for receipt of application is 26.12.2024. Applications received after the prescribed date will not be entertained.

NOTE (4) :- The entries put in column (5) are based on the Communities specified by the candidate in their Application forms and proved by them with necessary documents. The candidate whose Communities have not been correctly noted in the Ranked List as proved by them in their Application should intimate the fact to **the DISTRICT OFFICE**, **KERALA PUBLIC SERVICE COMMISSION DISTRICT OFFICE**, **KOLLAM** within one month from the Date of publication of the Ranked List to get the benefit of Reservation to which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in the Ranked List.

NOTE (5):- The candidates who wish to relinquish their claim for advice from the Ranked list shall submit an application in the format prescribed by the Commission to DISTRICT OFFICER, KERALA PUBLIC SERVICE COMMISSION DISTRICT OFFICE, KOLLAM. The format is available in the official website of the Commission. The request for relinquishment in respect of those who do not submit the relinquishment application in the format prescribed by the Commission will not be honoured under any circumstances. Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/ Central Government with Signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested copy of the ID proof bearing photograph as enlisted in the general conditions. The request for relinquishment along with the original of notarized affidavit and a self attested copy of the ID proof received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalization of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of vacancy based on which he/she is to be advised.

NOTE (6):- Since a common OMR Test with common candidates was conducted for this post, the marks awarded to candidates included in this Ranked List and mark of OMR test relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists (including NCA Notifications) which will be finalised on the basis of the common test.

NOTE (7):- (i) The A part and B part of OMR scripts will be destroyed after completing 6 months period from the date of finalisation of Ranked list incuded in the common test.

ii) The result of rechecking OMR answer scripts will be intiated in due course. But photocopy of OMR answer script will be issued only after the publication of the Ranked List for all the posts finalised on the basis of the common test.
