Note :- (3) **33 (Thirty Three)** candidates who have secured top most marks in the OMR examination are included in the main list of this Probability List. The marks secured by the last candidate in the Main List is **39.67 (Thirty Nine point six seven)** . For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes (and other reserved categories if any) necessary supplementary lists are prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note:- (4). The Probability List is prepared based on the details furnished by the candidates in the application and subsequent claims made will not be entertained at any stage.

Note:- (5) Candidates included in the Probability List should present and produce in person the original documents for One Time Verification. Date, time and Venue of OTR Verification will be published shortly through SMS and Profile Message.

Note:- (6) The Register numbers of those candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the Probability List without further notice.

Note :- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (8) Candidates belonging to Other Backward Classes included in this list are required to produce Non Creamy Layer Certificate issued by Village Officer as per G.O.(P) No.81/2009/SC/STDD dated 26.09.2009, candidates belonging to SC/ST are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificate Rules 2002 by the Revenue Authority not below the rank of Tahsildar and candidates claiming reservation under EWS category are required to produce EWS certificate as per G.O. (MS) No :02/2020/P&ARD dated 12/02/2020 issued by Village Officer as proof of their claim, along with other relevant documents at the time of OTR Verification.

Note :- (9) Copy of answer scripts of the OMR Test held on 04.05-2024 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No: **ER 2-1/12/2024 Dated: 29/10/2024.**
