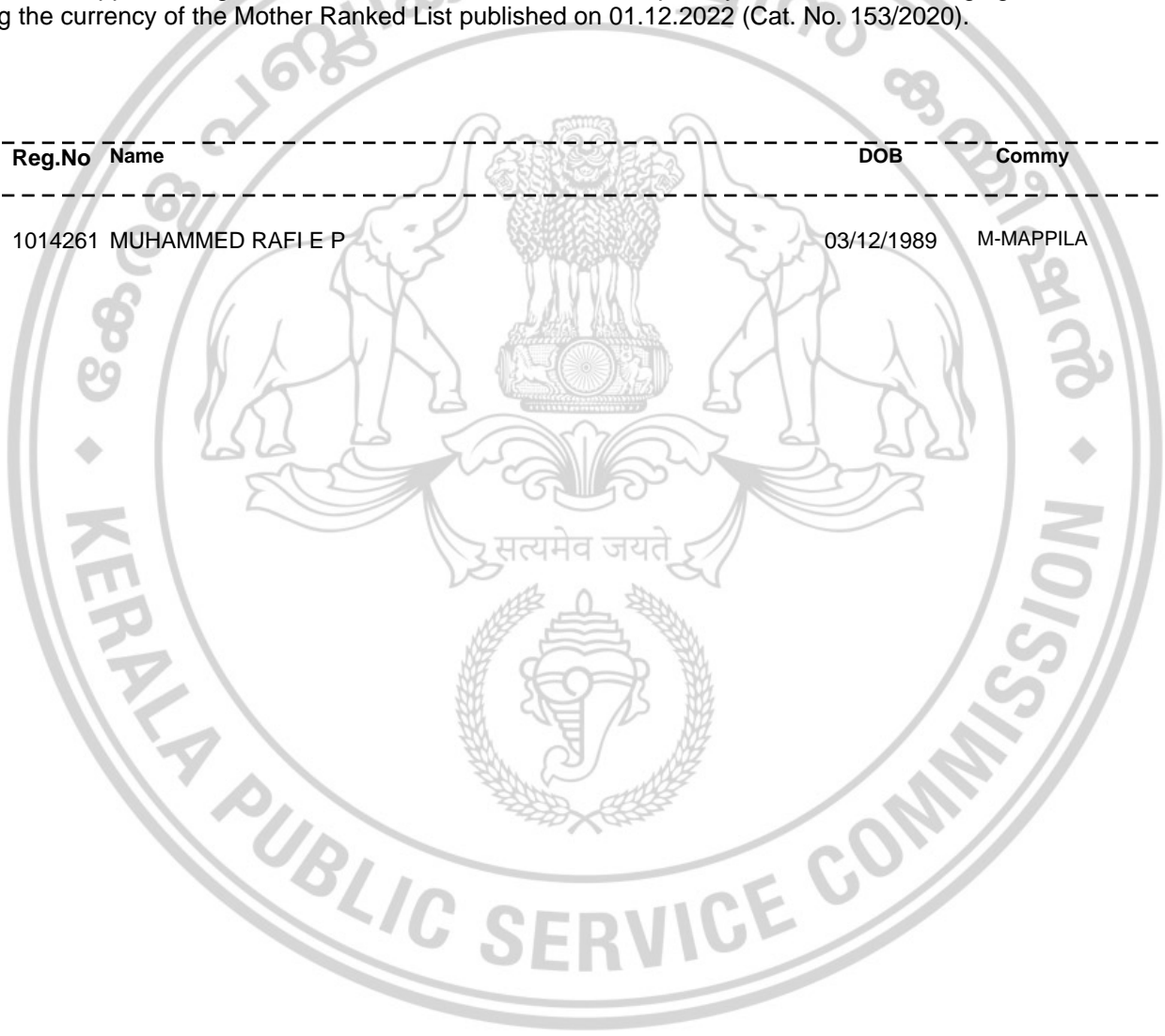

NOTIFICATION

The following is the list of candidate for selection to the post of **DRIVER CUM VEHICLE CLEANER GR. III (I NCA MUSLIM)(Category Number: 158/2023)** on Rs. **10,028-20,725/-** in **TRACO CABLE COMPANY LIMITED**, found suitable by the Commission and arranged in the order of merit, based on the OMR Test held on 29/11/2023 and Practical Test (T Test and Road Test) held on 24.10.2024 for recruitment against the NCA vacancies for Muslim community. This Ranked List is brought into force with effect from 10-12-2024 and will be valid until candidate is advised and appointed against the vacancies notified due to the paucity of candidates belonging to Muslim community during the currency of the Mother Ranked List published on 01.12.2022 (Cat. No. 153/2020).

NOTE (1) :- According to the existing procedure, revaluation of Answer script is not allowed. But Answer scripts will be rechecked if the candidates apply for through their One Time Registration profile from the Commission's official website www.keralapsc.gov.in by remitting the prescribed fee of Rs. 85 (Rupees Eighty Five only). The fee can be remitted by e-payment through the portal. Applications submitted in any other manner will not be considered. A period of 15 (Fifteen) days (i.e. on or before 24 /12/2024) time to apply for rechecking of Answer scripts will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission. Applications for rechecking received after the stipulated time will not be considered and fees once remitted will not be returned.

NOTE (2) :- Candidates who wish to obtain a photocopy of their OMR Answer sheets (Part A & Part B) relating to this selection shall submit online application through their One Time Registration profile from the official website of the Commission, www.keralapsc.gov.in by remitting the prescribed fee of Rs. 335 (Rupees three hundred and thirty five) via e-payment mode available in the portal. A period of 15 (Fifteen) days time to apply for photocopy of OMR sheets will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission. Application submitted in any other manner will not be considered. A copy of the answer sheet will be issued only once to a candidate. Copies of OMR sheets invalidated due to any defect will not be issued. Fees once remitted will not be returned.

NOTE (3) :- The Candidates who wish to relinquish their claim for advice from the Ranked List should submit an application in the format prescribed by the Commission. The format is available in the official website of the Commission. The request for relinquishment in respect of those who do not submit the relinquishment application in the format prescribed by the Commission will not be honoured under any circumstances. The request for relinquishment should be attested by a Gazetted Officer of State/ Central Government with Signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the general conditions. The request for relinquishment along with the original of Notarized Affidavit and self attested copy of an ID Proof received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalization of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.

NOTE (4) :- Since a Common OMR Test with common candidates for other posts was conducted for this post , the marks awarded to the candidates in the Ranked list will be published only after the publication of entire Ranked Lists (including NCA Notifications) which will be finalised on the basis of the Common Test.

NOTE (5) :- The result of rechecking of OMR answer scripts will be intimated in due course. But photocopy of the OMR answer scripts will be issued only after the publication of Ranked Lists for all the posts finalised on the basis of the Common Test.

NOTE (6) :- The A part and B part of OMR scripts will be destroyed after completing 6 months period from the date of finalisation of last Ranked list included in the Common Test held on 29/11/2023.
