For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes, Economically Weaker Section and Differently Abled ,necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (3) The Short List is prepared based on the details furnished by the candidates in the application and subsequent claim will not be entertained at any stage.

Note :- (4) The Register number of those candidates who do not produce the required documents within the prescribed time and those applications found otherwise defective will be deleted from the Short List without further notice.

Note :- (5) Candidates included in the Short List should present and produce in person the original documents for OneTime Verification and Interview. **Date,time and Venue of OTR Verification and Interview will be published shortly.**

Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post

Note :- (7) SC/ST Candidates included in the Short List are required to produce Community Certificate in Form III/Digitally signed and candidates belonging to other Reservation groups are required to produce Non Creamy Layer certificate as per G.O (P) No.81/2009/SC/STDD dated 26.09.2009 or EWS certificate vide GO (M S) No 2/2020/P&ARD dated 12-02-2020, issued by the Revenue authority at the time of OTR Verification.

Note :- (8) Copy of answer scripts of the OMR Test held on **01/10//2024** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No :ER 16-3/18/2024-KPSC dated 11.12.2024
