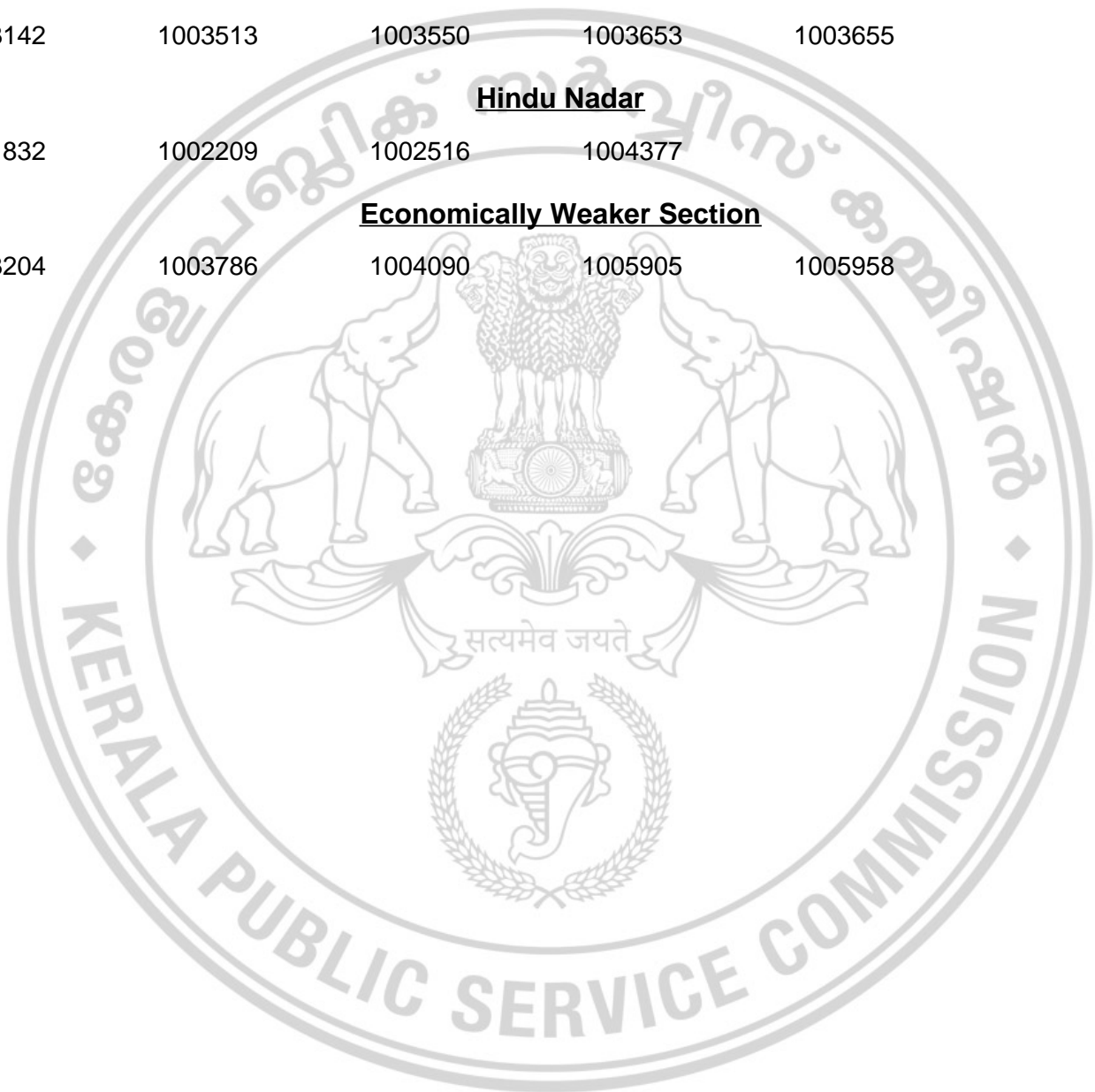

Note:- (2) The list has been prepared by including the number of candidates who have secured top marks in the OMR Test.

Note:- (3) The Probability list has been prepared based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage of selection.

Note :- (4) **27(Twenty Seven)** candidates who have secured top most marks in the OMR Examination are included in the Main List of this Probability List. The marks secured by the last candidate in the Main list is **50.33 (fifty (point) three three)** marks . For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes and Economically Weaker Section, necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note:- (5) Candidates included in the Probability List should present and produce in person the original documents for One Time Verification. **Date, time and Venue of OTR Verification will be intimated through Profile Message & SMS.**

Note:- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) Candidates included in the Probability List ,eligible for reservation are required to produce Non Creamy Layer Certificate as per G.O.(P) No. 81/09/SC/ST/DD dated 26.09.2009 / Community Certificate issued by the Revenue authority / EWS Certificate as per G.O. (MS)No :02/2020/P&ARD dated 12/02/2020 and shall produce the same along with the other documents at the time of verification of original documents.

Note :- (8) Copy of answer scripts of the OMR Test held on **03-05-2024** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No :ER6-3/3/2024-KPSC Dated:20.01.2025
