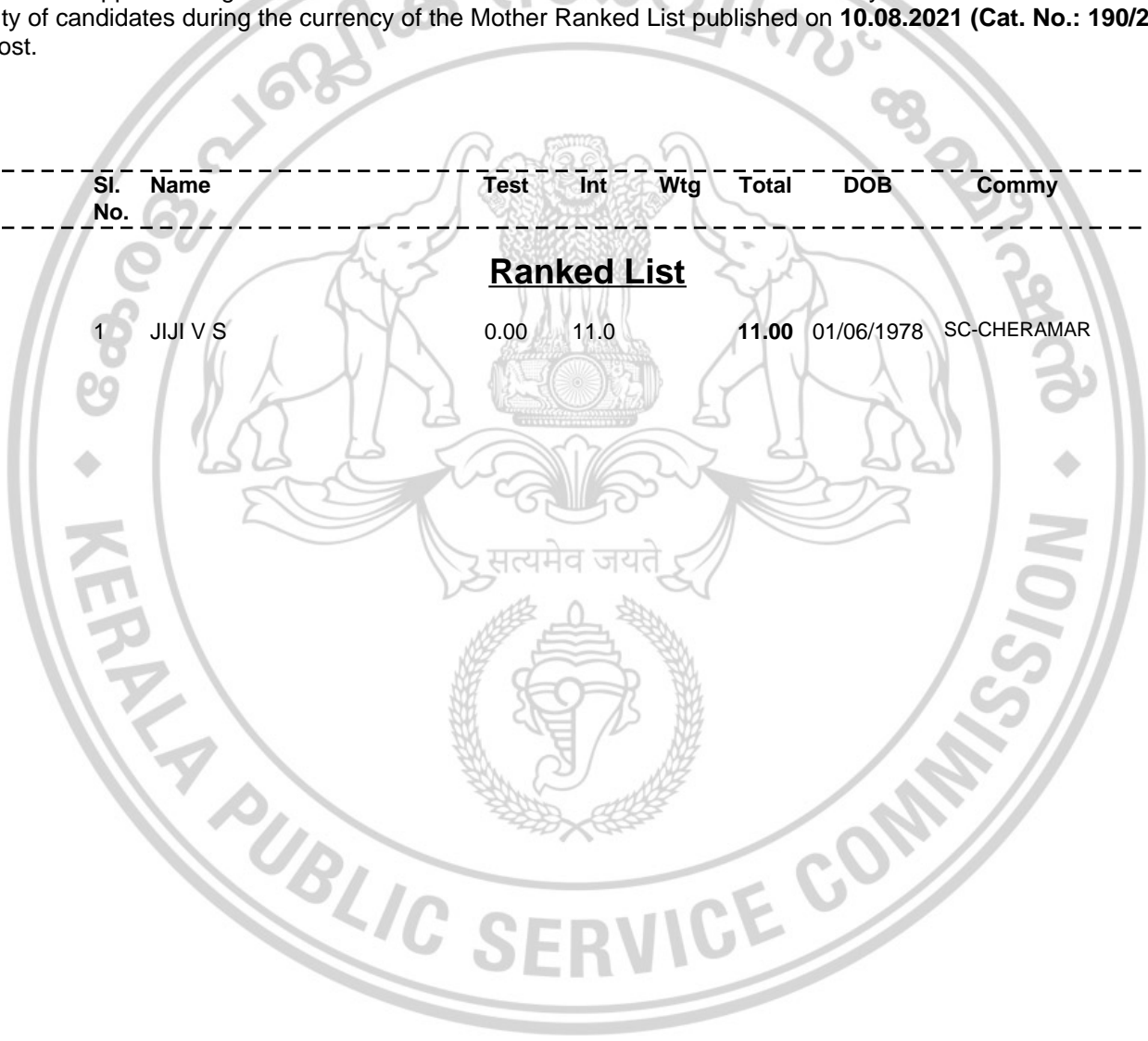

### NOTIFICATION

The following is the list of candidates for selection to the post of **Scientific Assistant (First NCA-SC) [Cat. No.: 072/2022]** on **Rs. 51400-110300/-** in **Ayurveda Medical Education Department**, interviewed and found suitable by the Commission and arranged in the order of merit, for recruitment against the NCA vacancies for SC community only. This NCA Ranked List is brought in to force with effect from **11.09.2024** and will be valid till the candidates are advised and appointed against the vacancies earmarked for the above community but remain unfilled due to the paucity of candidates during the currency of the Mother Ranked List published on **10.08.2021 (Cat. No.: 190/2019)** for the post.

**NOTE (1) :-** Since a common online test with common candidates was conducted for this post, the marks awarded to the candidates included in this Ranked List and the mark of online test relating to all candidates appeared for the test will be published only after the publication of the entire Ranked Lists which will be finalised on the basis of the common test.

**NOTE (2) :-** For Online Examination rechecking and revaluation are not allowed. Candidates who wish to obtain a print out of their answer sheets relating to this selection shall submit online application through their One Time Registration Profile from the official website of the Commission, [www.keralapsc.gov.in](http://www.keralapsc.gov.in) by remitting the prescribed fee of **Rs. 335/- (Rupees Three Hundred and Thirty Five only)** via e-payment mode available in the portal. A period of 15 (Fifteen) days time to apply for print out of answer sheet will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission (ie, **on or before 25.09.2024**). Applications submitted in any other manner (ie, via email/ Tappal/ Direct) will not be considered. A copy of the answer sheet will be issued only once to a candidate. Printout of the answer sheet will be issued only after publication of Ranked Lists for all the posts finalised on the basis of common test.

**NOTE (3) :-** The entries put in column (5) are based on the communities specified by the candidates in their application forms and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the Ranked List as proved by them in their application should intimate the fact to the **Deputy Secretary (Examinations-III), Kerala Public Service Commission, Thiruvananthapuram-695004** within one month from the date of publication of the Ranked List to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in the Ranked List.

**NOTE (4) :-** The candidates who wish to relinquish their claim for advice from the Ranked List shall submit an application in the format prescribed by the Commission to the **Secretary, Kerala Public Service Commission, Pattom, Thiruvananthapuram-695004**. The format is available in the official website of the Commission. The request for relinquishment in respect of those who do not submit the relinquishment application in the format prescribed by the Commission will not be honoured under any circumstances. The request for relinquishment in the prescribed format should be duly attested by a Gazetted Officer of State/Central Government with Signature, Name, Designation and Office Seal along with notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the general conditions. The request for relinquishment, along with the original of notarized affidavit and self attested copy of the ID proof, received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of vacancy, based on which he/she is to be advised.
