

NOTIFICATION

The following is the list of candidates for selection to the post of **BEAT FOREST OFFICER (FIRST NCA-VISWAKARMA)** on **Rs.20000-45800/-(PR)** in **FOREST DEPARTMENT IN THRISSUR DISTRICT**, found suitable by the Commission and arranged in the order of merit for recruitment against the NCA vacancies for Viswakarma community based on the OMR Test held on **09.05.2023**, Endurance test Test held from **15.11.2023 to 24.11.2023** and Physical Efficiency Test held from **15.10.2024** to **22.10.2024**. This Ranked List is brought into force with effect from **26.12.2024** and will be valid till the candidates are advised and appointed against the vacancies notified due to the paucity of candidates belonging to Viswakarma community during the currency of the Mother Ranked List published on **17.03.2020** (Cat No.582/2017).



NOTE (1) :- Candidates who wish to relinquish their claim for advice from the Ranked List shall submit an applicationin prescribed by the Commission to THE DISTRICT OFFICER, KERALA the format PUBLIC SERVICECOMMISSION, DISTRICT OFFICE, THRISSUR. The format is available in the official website of the Commission. The request for relinquishment in respect of those who do not submit the relinquishment application in the format prescribed by the Commission will not be honoured under any circumstances. The request for relinquishment in the prescribed format should be duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and office seal along with a Notarized Affidavit and a self attested copy of an IDProof bearing photographs enlisted in the General conditions. The request for relinquishment along with the original of notarized affidavit and self attested copy of the ID Proof received within 15 days from the date of publication of Ranked List in the Official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalisation of Ranked List. After the publication of the Ranked List, the requestfor relinquishment will be considered only if such request is received on or before the date of receipt of vacancy, based on which he/she is to be advised.

NOTE (2) - According to the existing procedure, revaluation of Answer script is not allowed. But Answer scripts will be rechecked if the candidates apply for through their One Time Registration profile from the Commission's official website www.keralapsc.gov.in by remitting the prescribed fee of Rs.85 (Rupees Eighty-Five only). The fee can be remitted by e-payment through the portal. Applications submitted in any other manner will not be considered. A periodof 15 (Fifteen) days time to apply for rechecking of Answer scripts will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission ie. on or before **24.01.2025**

NOTE (3):- Candidates who wish to obtain a photocpy of their OMR Answer sheets (Part A & Part B) relating to the selection shall submit online application through their One Time Registration profile from the official website of theCommission, www.keralapsc.gov.in by remitting the prescribed fee of Rs.335 (Rupees Three Hundred and Thirty-Fiveonly) via e-payment mode available in the portal. A period of 15 (Fifteen) days time to apply for photocopy of OMR sheets will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission ie. on or before **24.01.2025.** Application submitted in any other manner will not be considered. A copyof the answer sheet will be issued only once to the candidate. Copies of OMR sheets invalidated due to any defect willnot be issued.

NOTE (4) :- The entries put in column (5) are based on the Communities specified by the candidate in their Application forms and proved by them with necessary documents.

NOTE (5) :-Since a common OMR Test with common candidates was conducted for this post, the marks awarded to the candidates included in this ranked List and mark of OMR test relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists (including NCA Notifications) which will be finalised on the basis of the common test. The result of rechecking of OMR answer scripts will be intimated in due course.But photocopy of the OMR answer scripts will be issued only after the publication of the Ranked Lists for all the posts finalized on the basis of the common test held on 09.05.2023.

NOTE (6):- The A part and B part of OMR scripts will be destroyed after completing 6 months period from the date of finalisation of the last Ranked list included in the common test held on 09.05.2023.
