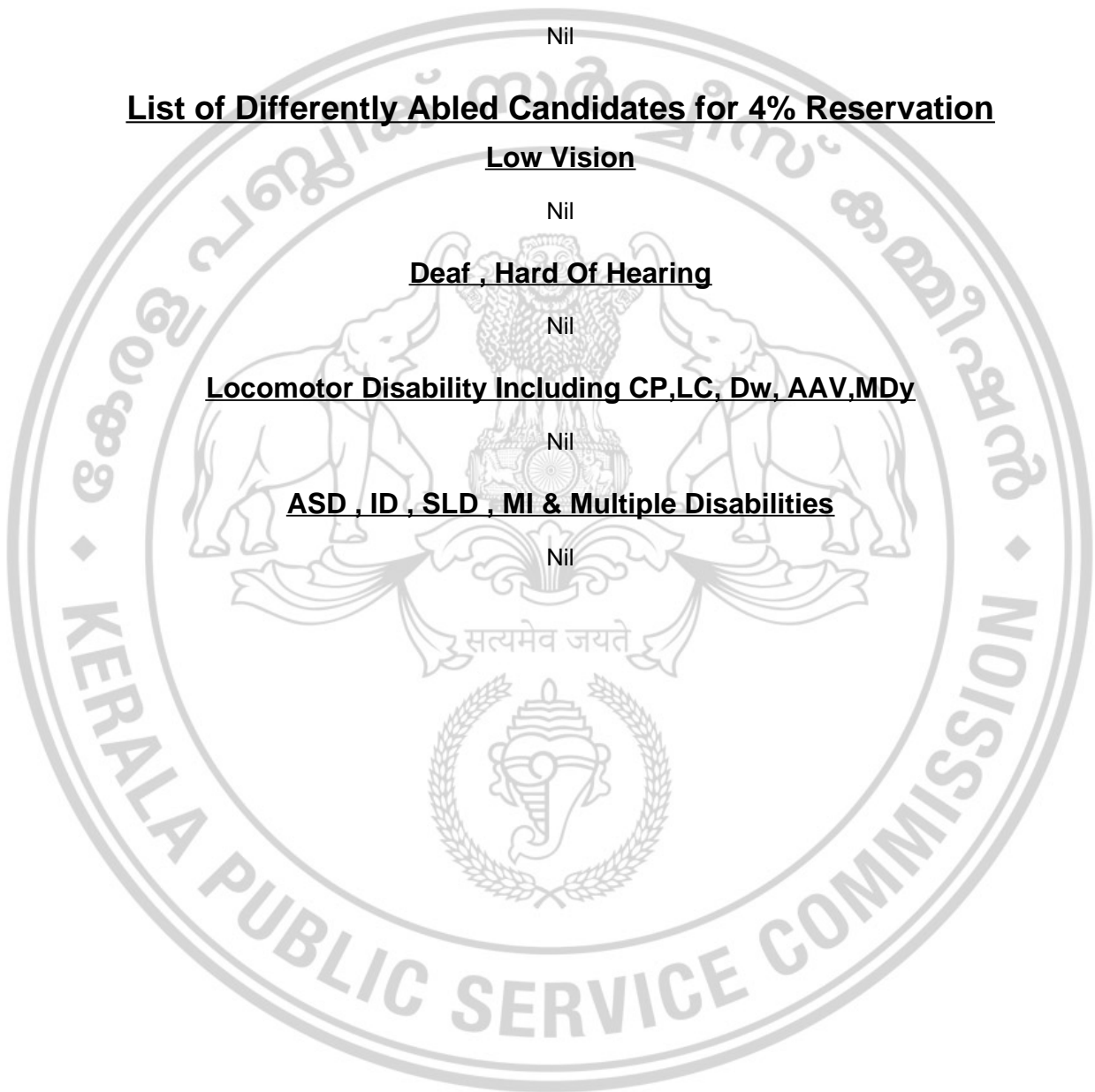

Note :- (3) **10 (Ten)** candidates who have secured top most marks in the Common OMR Examination are included in the Main List of this Probability List. The Marks secured by the last candidate in the Main List is **44 (Forty Four)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes , Other Backward Classes and Economically Weaker Sections, necessary supplementary list is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note:- (4) Candidates included in the Probability List should be present in person and produce the original documents for One Time Registration Verification. **Date,time and Venue of One Time Registration Verification will be intimated in due course through profile message and SMS.**

Note :- (5) SC/ST candidates included in the Probability List are required to produce Community Certificate(in Form III/Digitally Signed) issued by the competent Revenue Authority, candidates belonging to Other Reservation Groups are required to produce Non Creamy Layer Certificate issued by the Village Officer as per G.O(P) No 81/2009/SCSTDD dated 26.09.2009 and those belonging to Economically Weaker Section Category are required to produce EWS certificate in the format prescribed vide GO(MS) No 02/2020/P&ARD dated 12/02/2020 in proof of their claim along with other relevant documents at the time of One Time Registration Verification of original documents.

Note:- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be incorporated in the Ranked List to be published for the post.

Note :- (7) Copy of answer scripts of the OMR Test held on **13-08-2024** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Answer Scripts of no candidates are invalidated as per Notification No : .ER7-2/9/2024-KPSC dated 05.11.2024
