For the purpose of satisfying the rules of reservation of appointment to scheduled castes, Scheduled Tribes, Other Backward Classes and Economically Weaker Section categories if any , necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should be present in person and produce the original documents for One Time Registration Verification and Interview **Date,time and Venue of OTR Verification and Interview** will be intimated through profile message and SMS.

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be incorporated in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to Other Backward Classes included in the Short List are required to produce a Non Creamy Layer Certificate as per G.O.(P) No. 81/2009/SCSTDD dated 26.09.2009, SC/ST candidates are required to produce a Community Certificate in Form III or digitally signed certificate issued by the Revenue Authority not below the rank of Tahsildar and those belonging to Economically Weaker Section Category are required to produce EWS Certificate in the format prescribed vide GO (MS) No. 02/2020/ P & ARD dt 12/02/2020 in proof of their claim along with other relevant documents at the time of OTR Verification of original documents.

Note :- (7) Copy of answer scripts of the OMR Test held on **03-09-2024** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated as per Notification No : ER 2-1/17/2024-KPSC dtd 10/12/2024
