Note:- (1) Inclusion of Register Numbers in this list is purely provisional subject to scrutiny and admission of application on absolute basis. Inclusion of Register numbers in the Probability List does not confer any right on the candidate for inclusion in the Ranked List.

Note:- (2) The Probability List is prepared based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage.

Note:- (3) 153 (One Hundred and Fifty Three) candidates who have secured topmost marks in the OMR examination are included in the Main List of this Probability List. The Marks secured by the last candidate in the main list is **81.67 (Eighty one (point) six seven)** marks. For the purpose of satisfying the Rules of Reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes (and other reserved categories if any) necessary supplementary lists are prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note:- (4) Candidates included in the Probability List should present in person and produce the original documents for One Time Verification. **Date,time and Venue of OTR Verification will be published shortly.**

Note:- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belong to Other Backward Classes included in the Probability List , eligible for reservation are required to produce Non Creamy Layer Certificate as per G.O (P) No.81/09/SCSTDD dated 26.09.2009 or that obtained through e-district project in the format prescribed in G.O (Rt) No.3942/2018/RD dated 24.09.2018 and SC/ST candidates are required to produce Community Certificate (Form III/ Digitally signed) issued by the Revenue Authority not below the rank of Tahsildar and candidates who claim EWS reservation are required to produce EWS Certificate vide G.O.(MS)No.2/2020/P&ARD dated 12.02.2020 issued by the Revenue Authority along with other documents at the time of OTR verification of original documents.

Note :- (7) The Register number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Probability List without further notice.

Note :- (8) **The Selection pursuant to Notification vide Cat No. 428/2023 will be subject to the result of the OA [EKM] -1076/2024.**

Note :- (9) Copy of answer scripts of the OMR Test held on **30-04-2024** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : ER7-3/11/2024-KPSC dated 05-09-2024.
