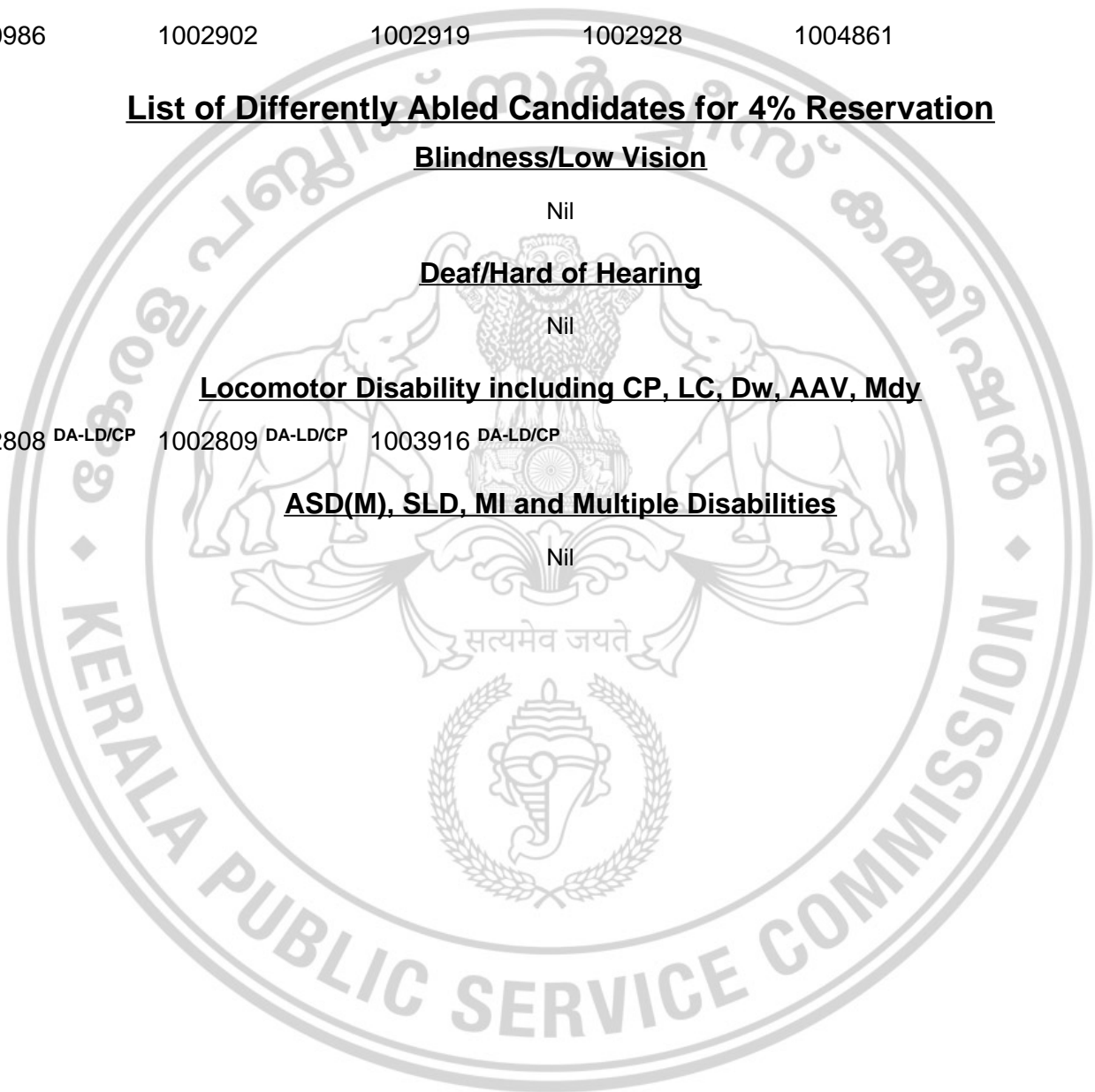

Note :- (2) **10 (Ten)** Candidates who have secured top most marks in the OMR examination are included in the Main List of this Short List. The marks secured by the last candidate in the Main List is **45 (Forty Five)** marks. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes (and other reserved categories if any) necessary Supplementary Lists are prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (3) Candidates included in the Short List should present and produce in person the original documents for One Time Verification and Interview. Date, time and Venue of One Time Verification and interview will be intimated to the candidates through profile message and SMS.

Note :- (4) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (5) Candidates belonging to Other Backward Classes, included in this List, are required to produce Non Creamy Layer Certificate as per G.O.(P) No.81/2009/SC/ST/DD dated 26/09/2009 issued by Village officer, SC/ST Candidates, included in the List, are required to produce Community Certificate (Form III or digitally signed) issued by the Revenue authority and Candidates who claim EWS reservation are required to produce EWS certificate as per GO(MS) No.23/2022/P&ARD dtd 04/10/2022, along with other documents at the time of OTR verification.

Note :- (6) Copy of answer scripts of the OMR Test held on 01-10-2024 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No.ER16-3/18/2024-KPSC.
