For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes (and the reserved categories if any) necessary Supplementary lists have been prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) The Short List is prepared based on the details furnished by the candidates in the application and subsequent claim will not be entertained at any stage.

Note:- (5) The Register Number of those candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the Short List without further notice.

Note :- (6) Candidates included in the Short List should present and produce in person the original documents for One Time Verification and Interview. **Date,time and Venue of OTR Verification and Interview will be intimated through Profile Message and SMS.**

Note :- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (8) Candidates included in the Short List and belonging to Other Backward Classes are required to produce Non-Creamy Layer Certificate issued by Village Officer as per GO(P)No.81/2009/SCSTDD Dtd.26.09.2009, SC/STCandidates are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificate Rules 2002 by the Revenue authority not below the Rank of Tahsildar and candidates claiming reservation under EWS category are required to produce Income and Asset certificate issued by Village Officer as per GO (Ms) No. 2/2020/P&ARD Dtd. 12.02.2020 as proof of their claim, along with other relevant documents at the time of OTR Verification.

Note :- (9) Copy of answer scripts of the OMR Test held on **01-10-2024** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
