Note :- (5) The Register Number of those candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the Short List without further notice.

Note :- (6) Candidates included in the Short List should present and produce in person the original documents for One Time Verification and Interview. **Date,time and Venue of OTR Verification and Interview will be intimated through Profile Message and SMS.**

Note :- (7) Candidates included in the Short List and belonging to Other Backward Classes are required to produce Non-Creamy Layer Certificate issued by Village Officer as per G O (P) No .81/2009/ SCSTDD Dtd.26.09.2009, SC/STCandidates are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificate Rules 2002 by the Revenue authority not below the Rank of Tahsildar and candidates claiming reservation under EWS category are required to produce Income and Asset certificate issued by Village Officer as per GO (Ms) No. 2/2020/P&ARD Dtd. 12.02.2020 as proof of their claim, along with other relevant documents at the time of OTR Verification.

Note :- (8) For Online Examination, rechecking and revaluation are not allowed but printout of answer sheets will be issued to those candidates who apply for it by remitting the prescribed fee after publication of Ranked List. Detailed instructions will be furnished in the Ranked List to be published for the post.
