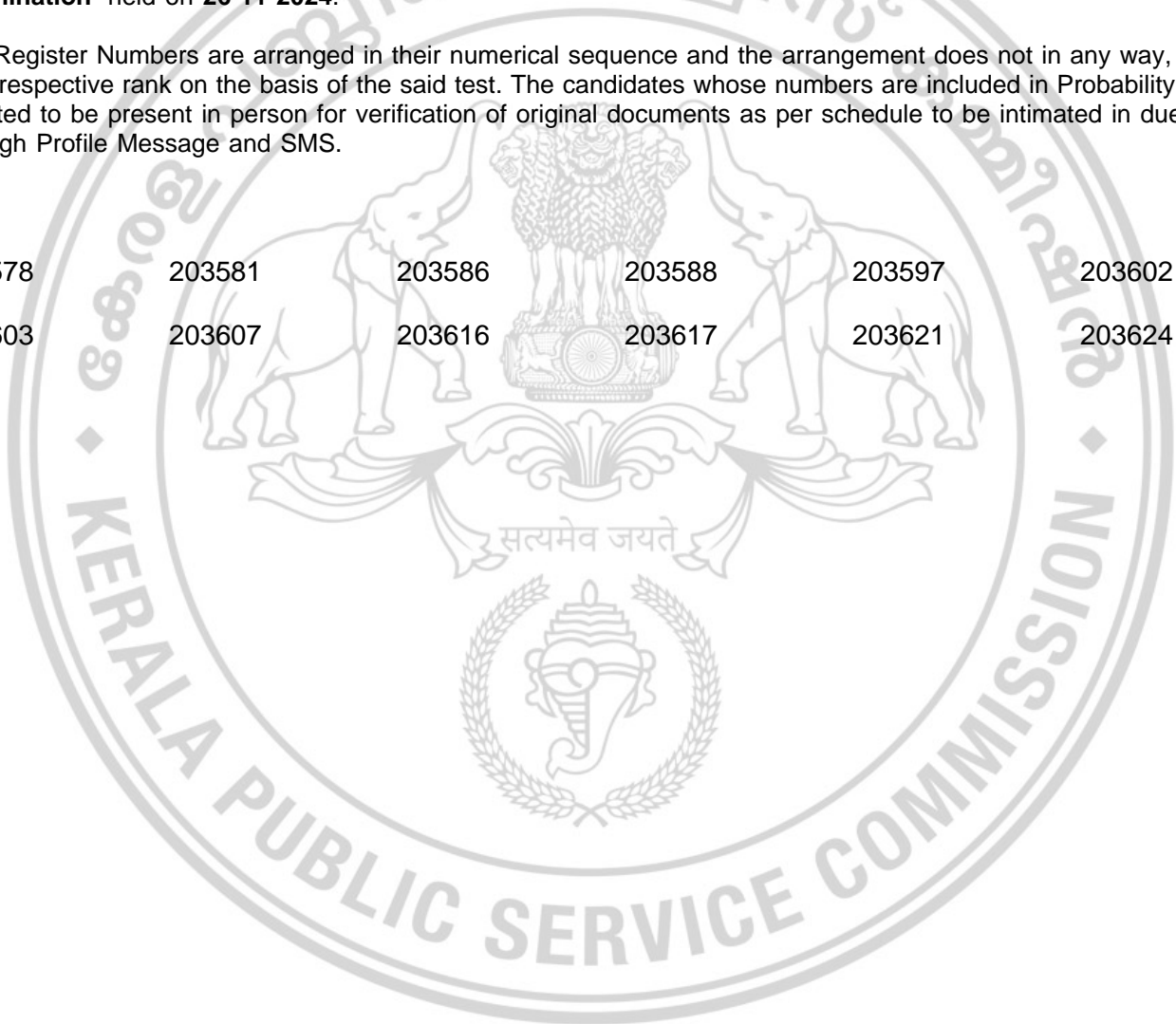

But print out of answer sheets will be issued to those candidates who apply for it by remitting the prescribed fee after the publication of Ranked List. Detailed instructions will be furnished in the Ranked List to be published for the post.
