Note :- (7) Candidates belonging to Other Backward Classes included in the list are required to produce Non Creamy Layer Certificate as per G.O(P) No. 81/09/SC/ST/DD dated 26-09-2009, candidates belonging to SC/ST are required to produce Community Certificate in Form III or Digitally Signed issued by the Revenue Authority not below the rank of Tahsildar and candidates belonging to Economically Weaker Sections are required to produce EWS Certificate issued by the concerned authority at the time of OTR Verification.
