The marks secured by the last candidate in the Main List is **71.00( seventyone )**. For the purpose of satisfying the rules of reservation of appointment Scheduled Castes, Scheduled Tribes, Other Backward Classes (and other reserved categories if any) necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note:- (4) Candidates included in the Probability List should present and produce in person the original documents for One Time Verification. **Date, time and Venue of OTR Verification will be intimated in due course.**

Note:- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to Other Backward Classes, included in this List, are required to produce Non-Creamy Layer Certificate as per G.O(P)No.81/2009/SCSTDD dated 26/09/2009 issued by Village officer and SC/ST candidates included in the List, are required to produce Community Certificate (Form III or digitally signed) issued by the Revenue authority not below the rank of Tahsildar and candidates who claim EWS reservation are required to produce EWS certificate vide GO (M S) No 2/2020/P&ARD dated 12-02-2020 issued by the Revenue Authority, along with other documents at the time of OTR verification.

Note :- (7) The Register Number of the candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Probability List without further notice.

Note :- (8) Copy of answer scripts of the OMR Test held on **08-11-2024** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : ER 7-2/4/2025 dtd 29.01.2025.
