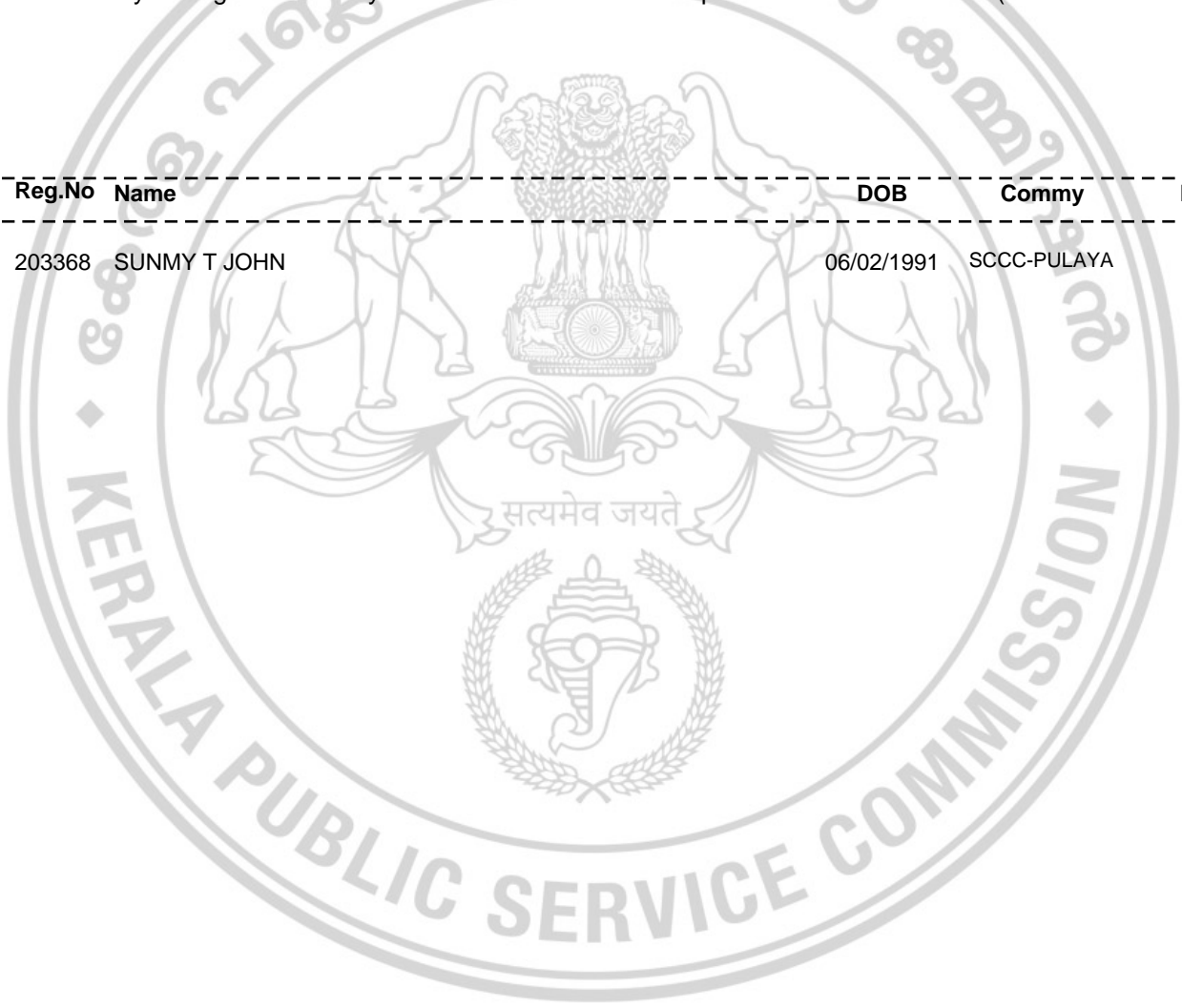

The following is the list of candidate for selection to the post of **Pharmacist Gr-II (Ayurveda) Fifth NCA SCCC (Category No.320/2023)** on **Rs. 27900-63700/-** in the **Indian Systems of Medicine Department in KOTTAYAM District**, found suitable by the Commission and arranged in the order of merit based on the Common Online Examination held on **26/11/2024**. NOTE (1) For Online Examination rechecking and revaluation are not allowed . Candidates who wish to obtain a printout of their Answer sheets relating to this selection shall submit online Application through their One Time Registration profile from the official website of the Commission, www.keralapsc.gov.in by remitting the prescribed fee of Rs.335(Rupees Three hundred and thirty five only) via e-payment mode available in the portal. A period of 15 (Fifteen) days time to apply for print out of answer sheet will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission . Application submitted in any other manner(i.e. via email/Tappal/Direct) will not be considered. Printout of the answer sheet will be issued only once to a candidate.

NOTE (2) :- The entries put in column (5) are based on the Community specified by the candidate in her Application form and proved by her with necessary documents. If the Community has not been correctly noted in the Ranked List as proved by the candidate in her Application , the fact should be intimated to The District Officer, Kerala Public Service Commission, District Office, Muttambalam P O,Kottayam-686004 within one month from the Date of publication of the Ranked List to get the benefit of Reservation which she is entitled to. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in the Ranked List.

NOTE (3) :- If the candidate wishes to relinquish the claim for advice from the Ranked List , the candidate shall submit an Application in the format prescribed by the Commission addressed to the District Officer, Kerala Public Service Commission, District Office, Muttambalam P O,Kottayam-686004. The format is available in the official website of the Commission. The request for relinquishment in respect of those who do not submit the Relinquishment Application in the format prescribed by the Commission will not be honoured under any circumstances. The request for relinquishment in the prescribed format should be duly attested by a Gazetted Officer of State/ Central Government with signature, name, designation and office seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the General Conditions. The request for relinquishment, along with the original of notarized affidavit and self attested copy of an ID proof received within 15 days from the date of publication of RankedList in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalization of the Ranked List. In the case of the requisitions of vacancies received after the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition based on which he/she is to be advised.

NOTE (4) :- Since a common Online Examination with common candidates was conducted for the post,the marks awarded to the candidate included in the Ranked List and mark of all the candidates who appeared for the Online Examination will be published only after the publication of all Ranked Lists(including NCA Selection) which will be finalised on the basis of the common test. Printouts of the Answer Scripts will be issued only after the publication of the Ranked Lists for all the posts finalised on the basis of the common test.
