Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. **Date, time and Venue of OTR Verification will be published shortly through Profile message and SMS.**

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates included in the short List who are eligible for reservation for Other Backward Classes are required to produce Non Creamy Layer Certificate as per G.O(P)No.81/09/SCSTDD dated 26.09.2009 or that obtained through e-district Portal in the format prescribed in G.O(Rt) No 3942/2018/RD dated 24.09.2018 and SC/ST candidates are required to produce Community Certificate issued by the Revenue Authority not below the rank of Tahsildar and candidates who claim EWS reservation are required to produce EWS Certificate vide G.O(MS)No.3/2024/P&ARD dated 25.04.2024 issued by the Revenue Authority along with other documents at the time of OTR verification of original documents.

Note :- (7) Copy of answer scripts of the OMR Test held on **30-10-2024** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No Candidate is invalidated as per Notification no **ER16-2/1/2025-KPSC dated 31.01.2025.**
