Note :- (5) The candidates who have secured **40.67 (forty (point) six seven)** marks and above are included in the Main list of this Short List .For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes,Scheduled Tribes,Other Backward Classes and Economicaly Weaker Section, necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (6) Candidates included in the Short List should present in person and produce the original documents for One Time Verification. **Date,time and Venue of OTR Verification will be published shortly.**

Note :- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post

Note :- (8) Candidates belonging to the Other Backward Classes included in the Probability List are required to produce a Non Creany Layer Certificate as per G.O. (P) no.81/2009/SCSTDD dated : 26.09.2009, SC/ST candidates are required to produce a Community Certificate either in Form III or digitally signed certificate issued by Revenue Authority not below the rank of a Tahasildar and an EWS Certificate issued by the village officer as per GO(MS) No.03/2024/P&ARD dated : 25/04/2024 in case of candidates having EWS reservation at the time of OTR.

Note :- (9) Copy of answer scripts of the OMR Test held on 28/10/2024 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification NoER2-2/18/2024-KPSC Dated 15/03/2024.
