- **NOTE (1)**:- The Ranked List will be in force till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of three years which ever is earlier. Candidates will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendancy of this list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.
- **NOTE (2)**:- According to the existing procedure, revaluation of Answer script is not allowed. But Answer scripts will be rechecked if the candidates apply for through their One Time Registration profile from the Commission's official website www.kerala psc.gov.in by remitting the prescribed fee of Rs. 85 (Rupees Eighty Five only). The fee can be remitted by e-payment through the portal. Applications submitted in any other manner will not be considered. A period of 15(Fifteen) days time to apply for rechecking of Answer scripts will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission ie, on or before 18/04/2025.
- **NOTE (3)**:- Candidates who wish to obtain a photocopy of their OMR Answer sheets (Part A & Part B) relating to this selection shall submit online application through their One Time Registration profile from the official website of the Commission, www.keralapsc.gov.in by remitting the prescribed fee of Rs. 335 (Rupees three hundred and thirty five) via e-payment mode available in the portal. A period of 15(Fifteen) days time to apply for photocopy of OMR sheets will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission ie, on or before 18/04/2025.. Application submitted in any other manner will not be considered. A copy of the answer sheet will be issued only once to a candidate. Copies of OMR sheets invalidated due to any defect will not be issued.
- NOTE (5):- Since a common OMR test with common candidates was conducted for this post, the marks awarded to the candidates included in this Ranked List and marks of OMR test relating to all candidates appeard for the test will be published only after the publication of entire Ranked Lists (including NCA Notifications) which will be finalised on the basis of the common test. The result of rechecking of OMR answer scripts will be intimated in due course. But photo copy of the OMR answer scripts will be issued only after the publication of the Ranked Lists for all the posts finalised on the basis of the common test.
- **NOTE (6)**:- The A part and B part of OMR scripts will be destroyed after completing 6 months period from the date of finalisation of last Ranked list included in the common test.
