

NOTE (1) :- For Online Examination rechecking and revaluation are not allowed . Candidate who wish to obtain a print out of their Answer sheets relating to this selection shall submit online application through their One Time Registration profile from the official website of the Commission, www.keralapsc.gov.in by remitting the prescribed fee of Rs.335 (Rupees three hundred and thirty five) via e-payment mode available in the portal. A period of 15 (Fifteen) days time to apply for print out of answer sheet will be allowed to candidates witheffect from the date on which the Ranked List is uploaded in the website of the Commission (ie on or before 23/04/2025. Application submitted in any other manner (i.e. via email/Tappal/Direct) will not be considered.

NOTE (2) :- Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/ Central Government with Signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the general conditions. The request for relinquishment received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalization of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.
