- Direct (i) A Degree in Ayurveda of a recruitment recognised University or equivalent qualification (A)
 - (ii) 'A' class registration with the Travancore-Cochin Medical Council."
- (4) for rule 7, the following rule shall be substituted, namely:—

"7. Appointing Authority.—The appointing authority for categories 1 to 3 in the Allopathy Branch, Categories 1 and 2 in the Homoeopathy and Ayurveda Branches shall be the Government and that for categories 4 to 8 of the Allopathy Branch and for category 3 and 4 in the Homoeopathy and Ayurveda Branches shall be the Director of Insurance Medical Services or any other officer authorised by Government."

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per G. O. (Ms.) No. 36/92/LBR. dated 4-5-1992, Government had created the post of Deputy Director (Homoeo) as a supervisory post for conducting periodical inspections of Homoeopathy institutions under the Insurance Medical Services Department so as to give technical advice and instruction for the efficient functioning of the Homoeo Wing. Likewise for the proper supervision and co-ordination of the Ayurveda Units of Insurance Medical Services Department, the post of Deputy Director (Ayurveda) was created vide G. O. (Ms.) No. 38/1997/LBR. dated 9-4-1997. These posts have not been included in the Special Rules for Kerala Insurance Medical Services.

Similarly the scale of pay of Medical Officers in Homoeopathy Department and Department of Indian System of Medicine is Rs. 11070-18450. The post of Medical Officers in Homoeopathy Department and Department of Indian System of Medicine have been included in their Special Rules for the State services. But in Insurance Medical Services Department, the posts still remain in the Subordinate Service Rules. In G. O. (P) No. 290/1997/Fin. dated 23-2-1997 it was ordered that all the posts in the scale of pay of Rs. 2000-3200 excluding the time bound higher grade scales would be declared, as gazetted. When the order was issued in 1997, the scale of pay of both the Assistant Insurance Medical Officer (Ayurveda) and Assistant Insurance Medical Officer (Homoeo) were 2060-3200. The revised scale of 2060-3200 as per the last pay revision is 11070-18450. Hence the post of Assistant Insurance Medical Officer (Ayurveda) and Assistant Insurance Medical Officer (Homoeo) are to be included in the Special Rules for Kerala Insurance Medical Services.

This notification is intended to achieve the above purpose.
